The Court has conferred with counsel and reviewed:

- (1) the Plaintiff Class' and the City of Detroit's proposed Settlement Agreement (Ex. 1);
- (2) the proposed Notice of Class Action Settlement (Ex. 2); and
- (3) the proposed Supplemental Notice to Certain Class Members (Ex. 3).
- (4) joint request to amend that Courts' Order Certifying Class Action of April 9, 2007.

IT IS HEREBY ORDERED that this Court preliminarily approves the Class Action Settlement, (Ex. 1), and approves the Notice of Class Action Settlement (Ex. 2), and the Supplemental Notice to Certain Class Members (Ex. 3), which are attached hereto and incorporated herein by reference.

IT IS FURTHER ORDERED that the Notice of Class Action Settlement (Ex. 2), and the Supplemental Notice to Certain Class Members (Ex. 3), shall be mailed to all members of the Plaintiff Class forthwith by counsel for Plaintiff Class via U.S. Mail, postage prepaid.

IT IS FURTHER ORDERED that, as set forth in the attached Notice of Class Action Settlement (Ex. 2), a hearing will be held on August 26, 2009, at 2:00 p.m., to determine whether the proposed Settlement is fair, reasonable, and adequate and whether this Court should give final approval to this Settlement.
